1 Purpose

The purpose of this Work Instruction (WI) is to describe the process of resolving Health Safety and Environment (HSE) issues by Southern Cross Electrical Engineering Limited (SCEE).

Supervisor	 Ensure the application of this work instruction. Monitor compliance with this work instruction.

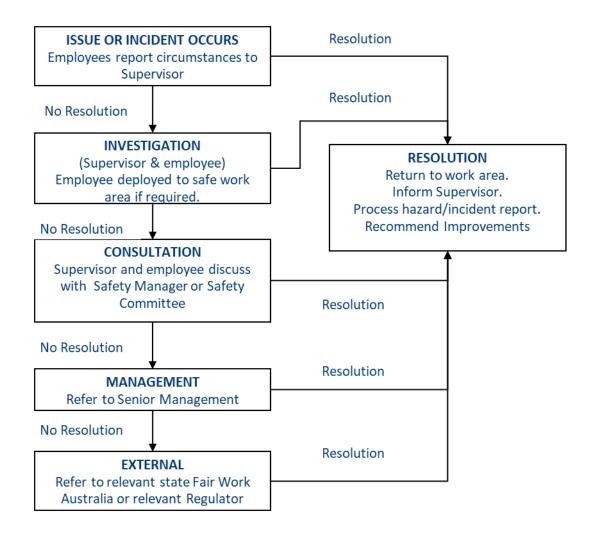

5 Action

Where an employee encounters what he believes to be a hazard or is allocated work to perform in what they consider constitutes an unsafe situation, they shall report and discuss the situation with their Supervisor.

If the matter is not resolved, the Supervisor and Safety Representative shall jointly obtain the relevant technical data and advice in an attempt to resolve the matter to the satisfaction of all concerned. At this stage employees shall be re-deployed to a safe working area.

In the event that the matter is not resolved, the Supervisor, Safety Representative and the HSE Advisor shall refer the issue to SCEE site management or the SCEE HSE Committee.

If the matter is not resolved the HSE Committee shall recommend the matter to be referred to Perth Senior Management for resolution.

In the event that the matter still does not get resolved, refer to WorkSafe WA, or if operating under the mines regulations refer to the District Inspector.

If an employee has reason to believe that the work will expose them to serious risk then the process in the flowchart above will be followed.
